- The resistance of the access control systems and operating devices used to operate the gates, to "non-mechanical" attack is not covered as it is outside the scope of LPS 1175: Issue 8. Likewise, the approval does not cover possible effects of any susceptibilities relating to the functionality and performance of any access control equipment that may be used to operate the gate. This is because the scope of access control devices and system configurations that may be used with these locking systems is "infinite". It is therefore recommended that specifiers and installers satisfy themselves that the components used are either resistant to mechanical
